

LIABILITY RELEASE AND INDEMNIFICATION FORM FOR TRAVEL

I, _____ (“Player”), a participant in one or more of the youth programs (“Program”) sponsored by the United States Polo Association (“USPA”), and _____, the Player’s parent or legal guardian (“Parent/Guardian of Player”), jointly request voluntary participation by Player in a polo event scheduled to be held in _____ from _____, 201__ through _____, 201__ (“Event”). As a condition to Player’s participation in the Event, including traveling to and from the Event, Player and Parent/Guardian of Player agree to each of the terms and conditions in this Liability Release and Indemnification Form for Travel (“Agreement”).

We, Player and Parent/Guardian of Player, recognize that participation in the Event shall include travel to _____. Before signing this Agreement, we have read, or have had the opportunity to read but have voluntarily and knowingly waived that right, the U.S. State Department’s currently published travel advisory. We consent to Player’s participation in and traveling to and from the Event and acknowledge that we fully understand Player’s participation in travel may involve risk of serious injury or death, including losses which may result not only from Player’s own actions, inactions or negligence, but also from the actions, inactions, or negligence of others. This includes all travel to and from the Event arranged by Player, Parent/Guardian of Player, the USPA and/or others including, but not limited to, transportation by plane, boat, train, van and/or car paid either by the Player/Parent/Guardian of Player or reimbursed by the USPA. We understand that if Player has any risk concerns regarding travel, he/she should discuss the risks associated with Player’s participation with Parent/Guardian of Player, the activity coordinators and event staff, before we sign this document and before travel begins. We confirm by our signatures below that we have had the opportunity to ask any questions of the USPA, the activity coordinators and event staff and we are fully informed and satisfied as to the nature of the Event, as well as the travel to and from the Event.

In consideration of allowing Player to participate in the Program and travel to and from the Event, we hereby release and hold harmless the USPA, members of its board of governors, and its officers, employees, members, volunteers, other participants, event coordinators and staff (collectively, the “Released Parties”), of and from, and do discharge and waive, any and all claims, demands, losses, damages, and liabilities that Player or Parent/Guardian of Player may have or sustain with respect to any and all damage and/or injury, of any type, arising out of his or her participation in the Program and travel to the Event. We also agree that if any portion of this Agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

I certify that Player is in good health, has no physical condition that would prevent participation in the Program and Event, and traveling to and from the Event, and is of such intelligence and maturity to make rationale and informed decisions while traveling.

Furthermore, we agree to use Player and/or Parent/Guardian of Player's personal medical insurance as a primary medical coverage payment if accident or injury occurs. We consent to emergency medical treatment for Player in the event such care is required. The emergency telephone contact number(s) for Parent/Guardian of Player are _____ and _____.

Indemnification by Parent/Guardian:

Parent/Guardian of Player further agrees to indemnify, save and hold harmless the Released Parties from any and all claims, demands, losses, damages and liabilities for indemnities, contribution or otherwise with respect to any damage and/or injury, of any type, arising from Player's participation in the Event, and travel to and from the Event. This provision shall not require Parent/Guardian of Player or Player to pay or otherwise reimburse the USPA for any travel related transportation or lodging costs.
